METAL BOXES DINARES

COINS IN IRAQ, NIQD closed and sealed metallic boxes with 40,000 notes (bills) RED COLOR 25000 DINARES issued in the years 2003 to 2006.

We have metal boxes of the so-called new red Iraqi dinars-issued from 2003 to 2006 exclusively. Tickets with a face value of 25,000 (twenty-five thousand) dinars, in sealed boxes of 40,000 bills each, for a total of one trillion dinars.

Directly with the table of redemption, which is responsible for paying these boxes and take them to their place of origin. They are all well-known boxes, but they are willing to have a 2nd skill. The metal box, which is the one that interests, goes inside a wooden box. To the wooden box you have to unscrew the eight screws of the cover and remove it, to remove the metal box.

PROCEDURES

1º- Direct an ICPO for the amount and edition desired, with all the data of the buyer, and of your bank.

2º- Along with the ICPO, it is necessary to send a dossier or a written document indicating the buyer who is, since a Due Diligence will be made, to check and verify the buyer.

3º- You must allow direct contact with the buyer, you do not want to deal with intermediaries, who will be respected regarding the payment of commissions.

The whole process must be conducted through our intermediation.

4º- It has the following types of boxes: Black, Blue and Red.

5º - The available boxes are personal boxes and boxes for the reconstruction of Iraq.

6º- After receiving the ICPO, with all the data of the client and his bank, the selling bank will send an invitation to the buyer and his bank, to perform the operation.

7º- The administrator of the boxes, belongs to the group that manages with the government of Iraq, the boxes of Dinars.

8th- Our administrator has a special number that accredits him internationally before banks and government entities as a merchant, this number entitles him to authorize the sale.

9º- The Seller will provide the seller of the experts or insurance company that have the codes of the boxes, in total 4 codes one outside and three inside, and it is these experts who will lead the buyer to make a secure purchase within the bank, (The operation is not done in another place), the operation is consigned inside the paying bank, the experts are in charge of doing all the work and extending the certificates of veracity and guarantee in the bank.

10º- We are in a position to sign the confidentiality agreement to respect the people who act as intermediaries.

11º- We recommend however that the intermediary signs an agreement with the buyer for the payment of commissions.

We are willing to listen to offers.
